1.0 Call to Order

8.0 **2020 Report Audited Financial Statements**

He notes our Revenue with a 356K surplus was not as high as expected due to COVID.

9.0 Subcommittee Reports

9.1 **Events** - Presented by Lenny Pasqualino

Lenny Pasqualino states the events put on by LIBIA were all well received by the community, and the Subcommittee hopes to put them on again next year. He reviews the following:

9.4 **Streetscape** - Presented by Gordon Pridham

Gordon Pridham reviews the following:

2021 Accomplishments:

- a) Neighbourhood beautification hanging flower baskets decorate BIA poles, plants/ flowers were planted in Lombardi Square, and CafeTO flowers/planters installed
- b) Graffiti Program
- c) Expanded Christmas Display
- d) Murals

Projects moved to 2022:

- a) Walk-of-Fame Project
- b) Street Cost Share Master Plan preliminary discussions re: 2022 goals have taken place with Palmerston Residents Association

10.0 **Proposed Program & Budget Presentation for 2022** - Presented by Maria Galipo The Taste of Little Italy and Cavalcade of Lights Events are 2022 focuses. We will be applying for Mural & Streetscape Grants and looking to secure year-round sponsorships. Marketing, Streetscape and Operations are also budget priorities as we want to keep Little Italy as a Destination Neighbourhood.

Maria Galipo reviews the budget summary, requirements and events listed in the Presentation which is made available to attendees. The 2022 proposed budget was provided to members in advance of the Meeting. She states that same as past years, 2022 levies will not be raised.

Lenny Lombardi motions to approve the 2022 Budget as presented. Motion seconded by Gordon Pridham. All are in favour. *Motion carries.*

11.0 New Business

11.1 Inclusivity Initiative

Lenny Lombardi asks Jeff Peters to review how the BIA plans to include more businesses in our membership. Jeff Peters states the Events Subcommittee plans to engage businesses that are not street level. The Subcommittee has started discussing new and unique ways to make sure all neighbourhood businesses are included in the benefits of the BIA. Funds have been Board approved for this initiative.

11.2 Sponsorship Approach

Alessandro Bertucci asks how the BIA is going to approach sponsorship for 2022. Connie Monardo responds that meetings with Hypitch and Sponsorship package development are underway and she is expecting a proposal next week.

11.2 Little Italy Merch Store

Anita Mancuso mentions the Little Italy Merch Store is expected to launch in 2022, and anticipates it will be a revenue stream.

11.3 Congratulations

Lenny Lombardi thanks the Board members for volunteering their time and congratulates them on a successful 2021!
